# TERMS AND CONDITIONS

## Payment Terms

1. Credit terms are strictly net 30 days from the end of the month in which the product was supplied.
2. Rivcow Environmental Pty Ltd (supplier) reserves the right to set and to vary without reference to the Applicant;
  - i. The amount of credit to be afforded
  - ii. Any limits which are to be imposed upon the provision of credit
  - iii. To amend, add or delete any conditions to this credit application
  - iv. To cancel any credit facility at its discretion.
3. Supply of goods will be suspended for any accounts overdue by more than 45 days. Rivcow Environmental Pty Ltd reserves the right to cease or suspend for such period as the Supplier sees fit, supply of any further goods to the Customer.
4. For credit accounts which are more than 60 days overdue, action for recovery will be implemented.
5. In the event of a dispute, the Customer will not be entitled to withhold payment of any undisputed amount due to the Supplier.
6. If the Applicant is a Corporation then the Applicant and person signing this application as Directors acknowledge by their execution of the application that they are Directors and Shareholders of the Applicant and that in consideration of Rivcow Environmental Pty Ltd providing credit facilities to the Applicant, the Directors jointly and severally covenant to Rivcow Environmental Pty Ltd in default of payment of any account by the Applicant be liable for the payment of all outstanding monies due to Rivcow Environmental Pty Ltd as if they were a principal.

## Title of Goods

1. Until the purchaser has paid all moneys due to the company for supply of the goods, the ownership of all goods supplied shall remain the property of Rivcow Environmental Pty Ltd and;
  - i. The purchaser shall hold such goods in its possession as bailee of the company, and
  - ii. Upon default in payment by the Purchaser of any amount due to Rivcow Environmental Pty Ltd, the Purchaser irrevocably authorises Rivcow Environmental Pty Ltd, its servants or agents to enter upon the premises where the goods are stored, for the purpose of taking possession of the goods and also to use all reasonable force to obtain such possession.
2. All risk in the goods and all insurance responsibility for theft, damage or otherwise in respect of the goods will pass to the Customer immediately upon delivery of the goods to the Customer.

## Delivery of Goods

1. All costs of freight and delivery of the goods to the agreed address shall be borne by the Customer.
2. If the Customer is unable or fails to accept delivery of the goods, the Customer will be liable for all costs incurred by the Supplier due to storage, double cartage, travel expenses, or any other related expenses.
3. Any period or date for delivery of goods stated by the Supplier is intended as an estimate only and is not a contractual commitment. The Supplier will use its best reasonable endeavours to meet any estimated dates for the delivery of goods.

## Credit Reporting

1. Notice of Disclosure of your credit information to Credit Reporting Agency -  
Under the Privacy Act a supplier may give credit reporting agency personal information about your credit application. This information includes -
  - i. Your name, date of birth, address, employer, and drivers licence number
  - ii. The fact that you have applied for credit and the amount
  - iii. Payments overdue more than 60 days and for which collection action has commenced
  - iv. Advice that payments are no longer overdue
  - v. Cheques drawn by you which have been dishonoured more than once
  - vi. In specified circumstances, that in the opinion of the supplier you have committed a serious credit infringement
  - vii. That credit provided to you by the Supplier has been paid or otherwise discharged
  - viii. The Supplier may obtain from a credit reporting agency a report containing personal credit information (or a commercial credit worthiness report) about the Applicant in relation to commercial or personal credit information
  - ix. The Supplier may give to and seek from any credit providers named in this credit application and any credit providers that may be named in a credit report issued by a credit reporting agency information about the Applicants credit arrangements. The Applicant understands that this information can include any information about the Applicants credit worthiness, credit standing, credit history or credit capacity that credit providers are allowed to give or receive from each other under the Privacy Act.
